## THEREFORE, BE IT RESOLVED,


The application / resumes with envelope be presented to the Head table by National Secretary.

Article VII Section 3 NSVA By-Laws: Natl. Cmdr. and Natl. V. Cmdr. having once succeeded himself/herself in the same office, a member shall be ineligible for election to the same office for a period of Three (3) years.

WHEREAS.

WHEREAS, the NSVA is over 75 years old, the By-Laws need to be reviewed on a periodic basis and adjusted for changes and advancements in both technology and business practices for the greater good of the organization.

WHEREAS, there exists no written record or obvious reason to impose an extended ineligible period longer than 2 years for re-election to the once held office of Natl. Cmdr. or Natl. V. Cmdr.

#### WHEREAS

WHEREAS, by reducing this ineligible period to Two (2) years, it offers past leaders, that have demonstrated their ability, willingness and desire to lead the NSVA into the future, providing an opportunity to stay involved and active in our organization.

### THEREFORE, BE IT RESOLVED,

BE IT RESOLVED, that Article VII Section 3 of the NSVA By-Laws be changed to read: a National Commander and National Vice Commander shall be ineligible for election the same office for a period of Two (2) years.
