WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration for participating in the All Seabee Reunion and other valuable consideration, I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE NSVA DEPARTMENT OF TENNESSEE, NSVA National, their officers, servants, agents, and employees (hereinafter referred to as RELEASEES) from and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.
2. To the best of my knowledge, I can fully participate in this activity. I am fully aware of risks and hazards connected with the activity, including but not limited to the risks as noted herein, and I hereby elect to voluntarily participate in said activity. I VOUNTARILY ASSUME FULL RESPONSIBIOITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH,, that may be sustained by me or any loss or damage to property owned by me, as a result of my participation in the reunion activities, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASES or otherwise.

6. I also understand, that I should, and am urged by, to obtain adequate health and accident insurance to cover any personal injury to myself which may be sustained during the activity or the transportation to and from said activity.

27, 28, 29, 30 - Leave 1100 Morning of 31 October 2024

All Hotel Reservations MUST Be Made Prior to 16 October 2024 (DEADLINE)

Individual Pay: A group block will be created and individuals are responsible for all Taxes, Room Rates and fees by way of personal payment. These room will be available until their release date indicated above. After this date, group members can receive the discounted rate based upon availability at the hotel All individual pay groups are subject to the standard 48 hour cancellation policy.

Non-Smoking Property: We are a non-smoking property **NO SMOKING IN THE HOTEL OR ON THE BALCONIES**. If evidence of smoking is found in the room or on the balcony, each room will be charged a \$250.00 Cleaning Fee.

Payment must be from the organization's credit card or check for both the deposit and final payment. If the group chooses to use a credit card, we must have a copy of the front and back of the card to confirm the exempt organization's name is on the card.

Cancellation: Please refer below for your cancellation deadline. All cancellations are subject to a 3% cancellation fee of the individual contract total.

Check-In Time is 4:00 p.m. and **Check-Out time** is 11:00 a.m. (early check-in/late-check out fees may apply).

MEETING SPACE POLICIES AND PROCEDURES

Contract Times: Meeting times indicated on the attached form are the maximum time the space will be provided. A representative must notify group sales in advance if the contract times change. Additional rental charges may apply for more time outside of your initial contract terms.

Occupancy & Availability: Grand Smokies Resort Lodge reserves the right to move your group to another meeting room space if the number in your group, or another group, greatly changes from the anticipated total.

Quiet Hours: In consideration of our guests, we have a 10:00 PM curfew on all amplified music (DJ's and/or Live Bands)

Final Headcount & Set Up: The group's final headcount and set up diagram is due no later than 30 days prior to the event. The meeting room will be set up as the group has requested; if any changes are requested after set-up has been completed, an additional charge may apply.

Smoking & Alcohol: We DO NOT ALLOW ANY ALCOHOLIC BEVERAGES in any of our meeting rooms, or public areas (pools, hallways, parking lots, lobby, etc.) There is no smoking or vaping anywhere inside the hotel. A \$250 fee will apply to the group total if evidence of smoking is found in your meeting room or hotel room. A designated smoking area is available, please ask the front desk for details.

Refundable Damage Deposit: A refundable damage deposit is due on the day of the event. At the end of the event, a Grand Smokies Resort Lodge staff member will inspect the room for any damages. Damages may include, but are not limited to, chipped paint, stained carpet, broken ceiling tiles, damaged dry wall etc. If no damages are found, the refundable damage deposit will be returned to the group leader before leaving property. In the event damages have occurred, the damage deposit will be held until a repair estimate can be obtained. If the damages do not exceed the amount of the damage deposit the remaining balance after repairs will be returned to the group leader once repairs are completed. If repairs exceed the amount of the damage deposit, Grand Smokies Resort Lodge reserves the right to bill the group leader for the remaining balance.

Event Insurance: Event insurance is required for any group using the conference center or using the conference center and all other meeting spaces. Please see the Special Event Insurance and Liability page for more information.

Amenities: Use of SWIMMING POOL is available to non-hotel guests for an additional fee of \$150.
